**New Applications:** This application will create one SHRIMP account. Once the application is received it can take up to three (3) business days before user will have access to their SHRIMP account. The SIF will notify the main contact by email when they have access to their account. Users will not have access to SHRIMP until full payment is received.

**Renewals:** Renewing SHRIMP extends the use of the SHRIMP tool an additional 12 months from the current expiration date. By renewing, your system agrees to continue to follow the terms & policies of the SHRIMP that are found at the end of this form. Please note that SHRIMP renewal will be processed after full payment is received. Please update any meter count changes and/or additional users.

The fee for SHRIMP covers creation of a DIMP plan for one (1) system. At the system's discretion it may grant other individuals (e.g. consultants, state regulators, employees of the system) access to the system's information on SHRIMP . \*

Please allow five (5) business days from application submission date for APGA SIF to verify user information. APGA SIF will notify the system main contact when approved. Please note that SHRIMP will not be accessible until full payment is received.

SHRIMP access is valid for one (1) year. Access to SHRIMP will be discontinued after 12 months unless a renewal payment has been processed.\*

If paying by check, please make payment out to "APGA Security and Integrity Foundation" with "SHRIMP" written in the memo section.

Systems must notify the SIF of service number changes in writing within 30 days of registering or renewing to receive a refund if they have put the wrong pricing tier.

A 100% refund will be given if the SIF does not approve the utilities request to prepare a DIMP plan through the SHRIMP program.

No refund will be given if a user chooses to discontinue SHRIMP after payment has been received.

This policy applies to the SIF SHRIMP integrity management plan. Operator qualification and compliance registration and refund policies are not applicable.

Yearly fee and system size categories for SHRIMP access are subject to change without notification.

A user may create more than one DIMP plans for subparts of the system within the same state.

In the case an operator may operate in multiple states but would have to register and pay separately for each state.

\*If multiple systems are registered under one SHRIMP plan (subdivided) or if a single system is subdivided within one SHRIMP plan, the total meter count must be disclosed to the SIF and meter count must be updated annually. SHRIMP cannot be subdivided across state lines. Each state will require a unique SHRIMP plan.
